**APPROVING AND AUTHORIZING THE EXECUTION OF AN AGREEMENT  
BETWEEN THE CITY OF DES MOINES AND STEVEN C. WALLACE AND ALYCE  
A. WALLACE REGARDING THE PROPERTY AT 1706 PENNSYLVANIA AVENUE IN  
DES MOINES, AND AUTHORIZATION TO ACQUIRE NECESSARY PROPERTY  
INTERESTS BY GIFT OR VOLUNTARY NEGOTIATION**

**WHEREAS**, on September 22, 2008 by Roll Call No. 08-1662, Council authorized and directed the City Manager to make application with the United States Department of Agriculture (USDA) for assistance under its Emergency Watershed Protection (EWP) Program for certain property owners in the City of Des Moines who experienced issues with land sliding on their property resulting from the flooding and rain conditions of 2008; and

**WHEREAS**, said application was made and funding pursuant to the USDA's EWP Program is available for construction of slope stabilization on the property located at 1706 Pennsylvania Avenue, Des Moines, Iowa and owned by Steven C. Wallace and Alyce A. Wallace; and

**WHEREAS**, City staff and the property owners have negotiated an Agreement regarding the City's sponsorship to obtain financial assistance through the EWP Program with the USDA, Natural Resources Conservation Service (NRCS) for the property, which Agreement is on file in the office of the City Clerk; and

**WHEREAS**, the City's Legal Department and the Real Estate Division of the Engineering Department will acquire the necessary easements for this project after property needs are determined, and the proposed Fair Market Value of the property interests to be acquired will be submitted to the City Council or the City Manager, as applicable, for approval.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF  
DES MOINES, IOWA:**

1. That the aforementioned Agreement between the City and Steven C. Wallace and Alyce A. Wallace is hereby approved, subject to review of title issues for the property by the Legal Department, and that following completion of said review by the Legal Department and receipt of necessary title clearance work acceptable to the Legal Department, the Mayor is authorized and directed to execute said Agreement, and the City Clerk is authorized and directed to attest to the Mayor's signature and return the Agreement to the Legal Department for future recording in the office of the Polk County Recorder, as applicable.
2. That the City's Legal Department and Real Estate Division be and are hereby authorized to proceed with the necessary activities and negotiations to acquire by gift or negotiation the necessary property interests for construction of the project, subject to approval by this Council, or approval of the City Manager in accordance with Section 2-201 (c) and (d), of the Municipal Code of the City of Des Moines, Iowa, as appropriate.

3. That the Fair Market Value of these parcels will be approved in accordance with established City policy. If the property owners agree to convey the property to the City in an amount based on the established fair market value, including an approved administrative settlement, the Finance Director is authorized and directed to issue checks in the amounts necessary to carry out these transactions and to pay any unforeseen additional costs certified by the Legal Department and the Engineering Department; the Real Estate Division Manager is authorized and directed to complete these transactions in accordance with standard real estate practices and state law requirements.

4. That the Real Estate Division of the Engineering Department is directed to obtain the Legal Department's review and approval of all closing documents prior to closing.

5. That the City Clerk is hereby authorized and directed to endorse upon the real estate documents the approval and acceptance of this Council and is further authorized and directed to deliver the aforementioned documents to the Real Estate Division Manager, who shall proceed to closing in accordance with standard real estate practices.
