WHEREAS, on July 14, 2008 under Roll Call No. 08-1164, the City Council approved a private construction contract in the amount of \$37,434.00, between Huber Grading, Inc., Dave Huber, President, 2531 N.E. 97th Place, Ankeny, IA, 50021 - as Contractor, and Cornerstone Family Church, Dan Berry, President, 3114 SW 61st Street, Des Moines, IA, 50321 - as Owner, for construction of Subgrade Preparation Improvements described as grading and subgrade preparation for improvements in the proposed Airport Industrial Park Plat 2 on SW 63rd Street at McKinley Avenue, Des Moines, IA as per Plan File Nos. 476-045/050, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
